
2022 Pip Hunter Trading Contest Terms and Conditions

- The 2022 Pip Hunter Trading Contest, hereinafter referred to as the Contest, is conducted jointly by ACY Capital Australia Limited (ACY LTD), an entity licenced in Vanuatu (VFSC 012868) with a registered address of Govant Building, 1276 Port-Vila, Vanuatu and ACY Securities Pty Ltd (ACY AU), an entity licensed in Australia (AFSL 403863) with a registered address of ACY Tower, L18/799 Pacific Hwy Chatswood, Sydney NSW.
- ACY AU is the promoter for Australian residents and ACY LTD is the promoter of non-Australia residents. Both ACY AU and ACY LTD trade under the name of ACY Securities, but there are specific conditions in this promotion that only apply to ACY AU clients.
- At all times, please refer to the relevant legal documents of ACY LTD, which can be found on our terms page [here](#), and ACY AU which can be found [here](#). CFDs are derivatives and you don't own or have any rights to the asset that underly the derivatives. Trading derivatives carry a high level of risk where you can lose substantially more than your investment.
- The Contest will last for six months, starting from the 1st July 2022 to 31st December 2022.
- The final ranking is settled by the Artificial Intelligence Money Manager Ranking (AI-MMR) formula which is our proprietary formula (the results of which will be disclosed on our website). The person with the highest AI-MMR score is the winner. In the event of a tie, the participant with the highest overall profit will be determined the winner.
- All trading histories will be captured after opting-in through our [ACY.Cloud](#) client portal for purposes of calculating the AI-MMR Ranking.
- The Contest leader board will be updated at <https://tradingcup.com/en> daily during the competition period.
- Participants can choose between the ACY LTD or ACY AU Standard, ProZero or Bespoke MT4 or MT5 live trading accounts via the [ACY.Cloud](#) client portal. Demo accounts do not qualify.
- ACY LTD and ACY AU reserves the right at its sole discretion to accept or decline the application of any participant in the Contest.
- There is no account opening minimum apart from the requirements to open the respective account at ACY LTD or ACY AU. For example, the minimum starting balance for a Standard account is \$50 and for the ProZero account it is \$200. There is no maximum.
- All trading histories, including deposits and withdrawals are calculated with the AI-MMR ranking.
- All open positions as of 21:59 on the 31st December 2022 (GMT), will be captured at this time for purposes of calculating the final Contest balance of all participants.
- The principal and profit can be withdrawn at any time. At ACY LTD, the minimum amount of withdrawal is \$USD50.
- The total prize pool is \$75,000 USD split between the top 50 participants in the following format. Please note that ACY AU clients will only receive a certificate of trading excellence, not a live trading account.

 - 4th place needs to trade 350 standard lots of FX/Precious Metals/Oils

 - 6th place needs to trade 200 standard lots of FX/Precious Metals/Oils

- You can opt-in multiple accounts to participate in the trading cup however, if any of your accounts are placed in the top 50 multiple times, you will only be eligible to win once. E.g. if your accounts are placed 2nd, 4th and 10th, you will be awarded the 2nd place prize of \$15,000 only. You will not be eligible for the 4th and 10th placed prize allocation.
- All prizes will be deposited into a new Standard trading account and issued to you before the 1st of March 2023.
- Participants will nominate their trading account(s) and there is no limit on the number of ACY LTD or ACY AU trading accounts you can have in the Contest.
- If your base currency is Japanese Yen, then you require 5,000 Yen as your starting capital.
- Participants must place at least ten round trip trades of any amount to be considered eligible for the prizes. A buy and sell (to open and close a position) is 1 round turn.
- Participants can trade the full list of instruments available through the ACY MT4 and MT5 platforms.
